

# **Guidelines for authors**

Dear authors,

Thank you very much for your interest in publishing an article in the journal CONSERVA -*Beiträge zur Erhaltung von Kunst- und Kulturgut* (CONSERVA-Contributions to the Preservation of Art and Cultural Objects).

After receiving your contribution at <u>redaktion-beitraege@restauratoren.de</u>, we will review the manuscript and contact you. The texts will be reviewed by the honorary editorial team. A decision will then be made about the inclusion of your article in the current issue of the journal. Editorial work is carried out in accordance with the editorial deadlines of March 1st or September 1st of each year in the periods of April to June or October to December. We assume that your manuscript has **not** yet been published and will not be offered to any other journal at the same time.

You are also welcome to send a preliminary working title or abstract of your proposed publication to the editorial team at the contact address above before submitting a full article.

The editorial team looks forward to your submissions!

We ask that the following editorial guidelines be observed:

# **Data submission**

- 1. General information: Contact information (e-mail, phone, address), article title, short title, keywords for the search function
- 2. Texts as doc or docx file by e-mail (no pdf files)
- 3. Figure captions as a list in doc(x) format
- 4. Tables in doc(x) format
- 5. Figures (TIFF, JPG) separately in appropriate resolution via file transfer service

#### **Manuscript structure**

- Contribution title
- Name of the author
- Abstract in English and German (approx. 150 words each)
- Continuous text with references to figures and notes as footnotes
- Author's address at the end of the text
- Bibliography
- Illustration credits

#### Texts

- Avoid formatting as much as possible (e.g. no headers, footers, or underlining)
- Insert numbered illustration references at the point in the text to which the illustration refers
- Set annotations and literature references as footnotes
  - » For books and for online sources with DOI with short title and page references as follows: BREPOHL 1987, P. 230; DEFEYT ET AL. 2018, P. 5
  - » For other online sources with complete URL and date of access

- Figures are numbered consecutively and are given a reference in the text after the reference word, or before the period at the end of the sentence or section to which the figure refers, as follows:
- (Fig. 7). or (Tab. 3)
- Figure files are labeled as follows: numbering\_author\_short title\_small/large/medium
- Each figure is listed separately with figure caption in the list of figures
- File size of the figures: for photo files and charts at least 300 dpi related to 100 % of the desired image size
- The origin and rights to the illustrations are listed in the illustration credits as follows:
